In this Licence for Publication “Review” means the Protocol for a Cochrane Review referred to above, including, without limitation, the protocol article itself and all supplementary or ancillary materials (if any) provided by the author(s) for publication (whether created by the author(s) themselves or third parties).

TEXT FOR REVIEW:

In this Licence for Publication “Review” means the Cochrane Review referred to above, including, without limitation, the review article itself and all supplementary or ancillary materials (if any) provided by the author(s) for publication (whether created by the author(s) themselves or third parties).

FOLLOWING TEXT FOR BOTH PROTOCOLS AND REVIEWS:

Authorship. I/we meet the following ICMJE criteria for authorship (<http://www.icmje.org>). I/we have made substantial contributions to the conception or design of the Review; and/or the acquisition, analysis, or interpretation of data for the Review; and/or the content of the Review. I/we have drafted the Review or revised it critically for important intellectual content. I/we approve the final version to be published. I/we agree to be accountable for all aspects of the Review and for ensuring that all questions related to the Review, including, without limitation, questions related to the accuracy or integrity of any part of the Review, are appropriately investigated and resolved.

Updating. I/we agree to maintain this Review according to Cochrane’s updating policy (<http://community.cochrane.org/editorial-and-publishing-policy-resource/cochrane-review-development/cochrane-review-updates>), which may be revised from time to time.

Licence for publication. I/we warrant that the Review does not infringe or violate any existing copyright, moral right, database right, right of privacy or confidentiality or any other intellectual property, personal, proprietary or statutory right. I/we warrant that the Review contains nothing misleading, obscene, libellous or otherwise unlawful; that all factual statements in the Review are true to the best of my/our knowledge and belief (having made full and proper enquiries); that the Review is accurate and reliable; and that its publication will not give rise to any liability on the part of Cochrane. I/we will indemnify Cochrane against any loss or damage which may result from any breach of warranty given by me/us.

Data sharing: Cochrane requires, as a condition for publication, that the data supporting the results in the Review will be available for download by users. Author(s) are required to provide a data availability statement and to confirm, where necessary, that appropriate permissions have been obtained for such use. Analyses and data management are preferably conducted within Cochrane's authoring tool, RevMan, for which computational methods are [publicly available](#). Scripts and artefacts used to generate analyses outside of RevMan and presented in the Review should be publicly archived and cited in the Review. Data are shared within the published Review directly from RevMan and author(s) will be responsible for assessing all data for quality, accuracy and completeness during editorial stages.

Authors' rights. In return for the grant of this Licence for Publication, the author(s) shall have the following rights:

- The right to post the Review as an electronic file on the author's own website and/or the author's institution's intranet, using any PDF version of the Review available in the *Cochrane Database of Systematic Reviews* (the "Published Version").
- The right to post the Published Version, on expiry of the 12 month period after publication ("Embargo Period"), in an institutional repository (an online archive of a research institution for the collection, preservation, and dissemination of digital copies of its authors' intellectual output); in any repository mandated by the author's funder; or in a Scholarly Collaboration Network (SCN) that has endorsed the STM article sharing principles ("Compliant SCNs"). If the Cochrane Review or Protocol was not prepared as part of the employee's duties or is not an official US Government publication, it is not US Government work.

US National Institutes of Health (NIH) employees

For NIH employees only, Wiley accepts the NIH Publishing Agreement and Manuscript Cover Sheet ("Cover Sheet").
